

TERMS AND CONDITIONS – \$10,000 Cash Giveaway

SECTION 1: PROMOTION

1. Promotion: \$10,000 Cash Giveaway
2. Promoter: Clintons Motor Group ABN 92 008 444 844, 11-23 Lasso Road, Gregory Hills 2557
3. Promotion Period: The Promotion will take place between Monday, 1 July 2019 and Monday, 30 September 2019 inclusive.

SECTION 2: ELIGIBILITY

4. Eligibility: To be eligible to enter the Promotion, the entrant must be 18 years of age or older and have purchased a New, Used or Demonstrator vehicle from within the Clintons Motor Group during the Promotion Period. Excluding Fleet purchases.
5. Non-Eligibility: In addition to the criteria for being eligible, persons are not eligible to enter the Promotion or win any Prize if: a. they are an employee of one of the Clintons Motor Group; b. they are an immediate family member, being a spouse, partner, sibling, parent or child, of any employee of the Clintons Motor Group; c. they are excluded for any reason from the property of the Promoter; d. any personal information or contact details are entered incorrectly; e. Fleet purchases

SECTION 3: ENTRY TO THE PROMOTION

6. Entry: Guests can earn one entry after making a vehicle purchase (and deposit taken/ finance approved) from within the Clintons Motor Group dealerships during the Promotion Period Monday, 1 July 2019 and Monday, 30 September 2019, maximum entry of 1 per person. Guest must sign the waiver provided to confirm their participation in this promotion.

SECTION 4: DRAWS

7. Prize Draws: At 6:30pm on Thursday, 3 October 2019, a representative of the Promoter will conduct a random barrel based draw of all entries in the Prize Draw. Clintons Motor Group to determine one Prize Winner, who must claim their Prize in accordance with Term 12.
8. Prize Winner: The Prize(s) described below in Section 5 will be awarded to the Prize Winner who has claimed their Prize in accordance with Term 12.

SECTION 5: PRIZE

9. Prize: The Prize for the Prize Winner comprise(s) of: \$10,000. This will be paid to the Prize Winner by EFT transfer within 7 days or at the time of vehicle delivery, if vehicle has not been delivered already.
10. Prize Value: The total maximum retail value of the Prize(s) is: \$10,000.

11. The Prize(s) are subject to the following conditions: a. No exchange of Prize: If for any reason, a Prize Winner cannot take any component of the Prize(s) or the Prize(s), then the Prize will be forfeited. b. SECTION 6: GENERAL CONDITIONS

16. Lost, Delayed Communication: The Promoter will not be responsible for any delayed, lost or misdirected mail or any other communication.

17. Release: To the fullest extent permissible by law, each entrant in the Promotion including without limitation the Prize Winner and any other person participating in the Prize(s), releases the Promoter from any claim, loss, damage, expense (including any claim for legal expenses), cost or charge sustained or in any way incurred by such entrant in connection with the Prize or their participation in the Promotion or Prize. The Promoter, its related bodies corporate, their officers, employees and agents will not be liable for any loss, damage or personal injury whatsoever (including but not limited to direct, indirect, consequential and economic loss) suffered or sustained

in connection with this Promotion, the promotion of this Promotion, or the use of any Prize, except for any liability which cannot be excluded by law. 19. Disputes: In the event of a dispute, the decision of the Promoter is final and binding and no correspondence will be entered into.

20. Privacy Notice: The Promoter may collect entrants' personal information, including name and contact details, for the purpose of conducting the Promotion, including publicising the results of the Promotion. Uses may also include future promotional, marketing and publicity purposes. The Promoter may disclose this information to an associated entity or other companies acting on the Promoter's behalf, which may include those located overseas in accordance with the Promoter's Privacy Policy. By entering this Promotion, unless otherwise advised by the entrant, each entrant consents to the retention and use of their information in this manner.

Consent to use of Personal Information for Marketing Purposes: Furthermore, by entering this Promotion, unless otherwise advised by the entrant, each entrant consents to the retention and use of the information collected pursuant to Term 20 by the Promoter, which trades as Clintons Motor Group. Uses may include future promotional, marketing and publicity purposes without any further reference or payment or other compensation to the entrant.

Alteration of Terms and Conditions: Subject to approval being granted under Condition 12 of the general conditions attaching to Trade Promotion Lotteries issued by NSW Fair Trading, the Promoter reserves the right to alter these terms and conditions to address any misinterpretation, misinformation or misunderstanding that may arise in the application of these terms and conditions, as is permitted by law. The Promoter's decision will be final.

23. Acceptance of Terms and Conditions: Participation in the competition constitutes an acceptance of these terms and conditions.
